The lecture is followed by a five-hour mass casualty exercise utilizing cadaver specimens. Participants will work in teams to identify over 25 remains from a mock air crash incident. The teams will work on a combination of skeletonized and formalin-fixed cadaver specimens. # Faculty

## Itiel E. Dror, PhD

Dr. Dror is a cognitive neuroscientist. Interested in the cognitive architecture that underpins expertise, he attained a PhD at Harvard University. He has been working with the U.S. Air Force, frontline police, medical surgeons, financial traders, and other expert domains, finding ways to enhance decision quality and performance. In the forensic domain he has demonstrated how contextual information can influence the judgments and decision making of experts; he has shown that even fingerprint and DNA experts can reach different conclusions when the same evidence is presented within different extraneous contexts. Dr. Dror is the Chair of the OSAC Forensic Human Factors Group and is working with forensic examiners in the US and in the UK (as well as in The Netherlands, Finland, Canada, and Australia) in providing training and implementing cognitive best practices in evaluating forensic evidence. He is also on the National Commission on Forensic Science (NCFS) Human Factor Subcommittee.



For his work in training and improving forensic work, Dr. Dror has received the ABP (Association for Business Psychology) 2014 Annual Award for “Excellence in Training.” Dr. Dror has published over 100 research articles, and has been extensively cited in the American National Academy of Sciences Report on Forensic Science, and the UK Fingerprint Public Inquiry on fingerprinting. ## R. Lance Fogarty, CISSP, CCE

Upon founding Protegga in 2003, Lance advised his clients on network and computer security using his nearly thirty years of experience in corporate networks and computing systems, all facets of the internet, physical, network, computer, and Internet security. Lance has focused solely on the Computer Forensics, e-Discovery, Data Collection, and Litigation Support aspects of computer security since 2005. Lance has assisted clients in retrieving and analyzing computer evidence in cases involving Breach of Fiduciary Duty, Theft of Intellectual Property, Theft of Trade Secrets, Fraud, Forgery, Breach of Contract, Hidden Assets, Child Custody, Securities and

## David R. Fowler, MD

A native of Rhodesia—now known as Zimbabwe—David R. Fowler attended medical school at University of Cape Town in South Africa and completed a five-year residency in forensic pathology. Dr. Fowler came to the U.S. in 1991 for a residency in anatomic pathology at University of Maryland Medical Center. He did a two-year fellowship in forensic pathology at the Office of the Chief Medical Examiner and

remained as an Assistant Medical Examiner. Dr. Fowler was promoted to Deputy Chief Medical Examiner in 1998 and named Chief Medical Examiner in 2002.

Dr. Fowler has had numerous articles published in medical journals, and his work has been included in a number of books. He holds numerous professional memberships, committee positions, and teaching services. He lectures to federal, state and local agencies and organizations.



## Lois Gibson

Lois Gibson is recorded in the Guinness Book of Records as The World’s Most Successful Forensic Artist. Her sketches have helped law enforcement bring in over 1,266 criminals. She is a graduate of the University of Texas at Austin with a Bachelor of Fine Arts with Honors and the FBI Academy Forensic Artist Course. She now teaches this profession at Northwestern University. She completed the textbook for her profession titled *Forensic Art Essentials* released by Elsevier Academic Press December 2007. Her true-crime book *Faces of Evil* which profiles some of her most fascinating cases was co-authored with renowned writer Deanie Francis Mills. Both



books are available in book stores and online. Her 2007 sketch of an unidentified murdered baby girl called “Baby Grace” prompted Rileigh Ann Sawyers’ grandmother to identify her for the Galveston authorities resulting in the apprehension and conviction of her murderers. In the last six months she has appeared on TRU TV’s *Forensic Files* (Clear Lake Texas quadruple murder) and A&E’s *First 48* (the segment titled “Cold and Callous”). Lois has been profiled in and on ABC’s *20/20*; *Dateline NBC*, *People Magazine*, CNN, *Larry King Live*, the *CBS Early Show*, etc.

## Amanda Klinger, Esq.

Amanda Klinger, Esq. is nationally recognized as an expert in cyberbullying, school safety, and the law. She delivers trainings and lectures throughout the United States and abroad.

Ms. Klinger has past experience both as an attorney and an educator. After earning a degree from Denison University, she worked as an elementary and secondary teacher before graduating from the University of Akron School of Law. Her expertise in active shooter response, crisis management, vulnerability assessment and mitigation, lockdown enhancements, cyberbullying, and the use of technology during crisis events is derived from her work with Dr. Amy Klinger in developing training courses for the Department of Homeland Security and the Federal Emergency Management Agency.

Ms. Klinger frequently keynotes and presents at regional and national education, law enforcement, and safety conferences related to crisis response, technology, and legal issues.

She is the Founder and Director of Operations for The Educator’s School Safety Network.

Dr. Amy Klinger is nationally recognized as an expert in school safety and crisis management. She delivers trainings and lectures throughout the United States and abroad.



Dr. Klinger has over 28 years of experience as an educator and administrator. She brings a practitioner's perspective to the critical concerns of school crisis response. With her expertise in active shooter response, crisis planning and preparedness, vulnerability assessment and mitigation, as well as lockdown enhancements, Dr. Klinger combines a knowledge of law enforcement procedures with the practical experience of educational administration.

Dr. Klinger is an Associate Professor of Educational Administration at Ashland University and is Founder and Director of Programs for The Educator's School Safety Network.

## Henry C. Lee, PhD

Dr. Henry C. Lee is one of the world's foremost forensic scientists.



Dr. Lee's work has made him a landmark in modern-day forensic sciences. He has been a prominent player in many of the most challenging cases of the last 50 years. Dr. Lee has assisted police from 46 countries in helping to solve more than 8,000 cases; such as the murder of Jon Benet Ramsey, the suicide of Vincent Foster, kidnapping of Elizabeth Smart, death of Chandra Levy, the reinvestigation of the Kennedy assassination and the Casey Anthony case.

Dr. Lee is currently the director of Forensic Research and Training Center and Distinguished Chair Professor in Forensic Science of the University at New Haven. He was the Chief Emeritus for Connecticut State Police during 2000 to 2010, Commissioner of State Police & Public Safety for Connecticut during 1998 to 2000, and was the Chief Criminalist & Director for Forensic Lab from 1976 to 1998. He currently serves as advisor/consultant for more than 150 law enforcement agencies around the world.



## Richard Souvion, DDS, ABFO

Dr. Richard Souvion serves as the Chief Forensic Odontologist for the Miami-Dade County Medical Examiner Office, a position that he has held since 1967. Dr. Souvion received his undergraduate degree at the University of Miami and Emory University School of Dentistry in 1960. In addition to his dental practice, Dr. Souvion has served in the field of Forensic Odontology since 1967 and has pioneered the field for the United States. He is the founding member of the American Board of Forensic Odontology and holds the #2 certificate as a Diplomate. He was one of the eight founding members of the Odontology section of the American Board of Forensic Odontology.



Dr. Souvion has provided the first bite mark testimony in the State of Florida and several other southern states. He has served as an expert witness in some high profile cases including the State of Florida versus Theodore Bundy, the West Memphis Three case, recently featured on *48 Hours* and the Abdul Hossan murder case in Miami Dade County recently featured on *Dr. G Discovery Health*, the Kennedy Brewer case on *60 Minutes* and the Philip Spector murder case and several others on *Forensic Files*, *CNN*, *Dateline*, etc.

## David L. Wells, DDS, MS, Col, USAF, DC

David L. Wells, DDS, MS, Col, USAF, DC currently serves as the Director of Dental Operations Joint Base Elmendorf-Richardson in Alaska and as Military Consultant to the Surgeon General for Oral & Maxillofacial Pathology.



## Bradford J. Wing, MS

Mr. Wing is employed by the National Institute of Standards and Technology (NIST), where he serves as Biometrics Standards Coordinator. He is the chair of the Inter agency Forum on Biometrics and Identity Management, former chair of the White House Subcommittee on Biometrics, founder and past chair of the Department of Homeland Security (DHS) Biometrics Coordination Group, current Ombudsman of the National Information Exchange Model Biometrics Domain, and current chair of the Standards Developing Organization ANSI/NIST-ITL. He has worked in biometrics as a researcher, practitioner, developer, manager and system designer for over 25 years. Mr. Wing has over 20 years of experience in law enforcement as head of research projects at the Immigration and Naturalization Service and as the Chief Biometrics Engineer for DHS. Mr. Wing also has a technical background in systems analysis, having worked at Brookhaven National Laboratory and the Department of Energy in Operations Research – a field of mathematical engineering.
